#### Pre-Amble

*The Sea Ventures Super Series 2023 is a new series designed to offer a winter series with a difference - the same amount of sailing as a 'traditional' seasonal series, condensed over fewer weekends, with an enhanced social scene. The crew limit has been chosen to appeal to competitors who might not normally race a season series events, or those who don't want to co-ordinate a larger crew 'out of season'. The test event is principally a way to test the format and several race/series management tools (some unseen by the competitors!). We may also take the opportunity to test a variety of technology solutions including start and finish line technology or data logging. Your participation in this test event is much appreciated, of course we hope your feedback will be positive, but we know you won't hold back in letting us know if something is not to your liking. An advantage of a test event is that we can alter things as we go. We will hold a Zoom call on the Wednesday following each round, where we will gather feedback, all competitors are welcome to join. Where possible we will incorporate any feedback in the next round. Of course, if you wish to discuss something privately, please do get in touch.*

## 1. RULES

- 1.1 In entering all participants agree to be bound by these clauses:  
The Regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS)2021 – 2024, the Sailing Instructions (SI), the Class rules, and the Cowes Harbour Commissioner’s Local Notices to Mariners (LNTM).  
In the event of conflict, the Sailing Instructions shall prevail.  
The Race Officer, Race Committee or Protest Committee appointed by the Island Sailing Club (ISC) may modify or interpret any RRS rule [except those listed in RRS 86.1 (a) or (b)] in accordance with RRS2 “Fair Sailing” or for any other reason.
- 1.2 Competitors must comply with any current rules/guidance in force at the time of each race.
- 1.3 The official language of the regatta will be English. If there is a conflict between languages English will take precedence
- 1.4 IRC Rules parts A, B and C will apply
- 1.5 Competitors shall comply with World Sailing Offshore Special Regulations for Category 4 races.

## 2. ELIGIBILITY AND ENTRY

- 2.1 The Regatta is open to IRC Rated boats that have a TCC from 0.990 up to 1.090
- 2.2 All IRC boats shall have a valid IRC certificate.
  - a. Crew Numbers - IRC Rule 22.4.2 is deleted and replaced by “The Minimum number of crew that may sail is two and the maximum number is four that may sail aboard.
  - b. Rating Changes - Boats shall be scored using the TCC valid on the date of the first race she sails in the series.
  - c. The rating deadline under IRC Rule 8.2.1(c) is noon on the Wednesday before the first race entered. Boats may not change their declaration once submitted.
- 2.3 All competitors shall comply to the World Sailing OSR Category 4

## 3. FEES

- 3.1 The Sea Ventures Super Series is a Test Event and no entry fees will be charged

## 4. SAILING INSTRUCTIONS

- 4.1 Sailing Instructions will be available to download online from the Sea Ventures UK website after 0900 on 25<sup>th</sup> October 2023
- 4.2 The Sailing instructions will consist of the instructions in RRS Appendix S. Standard Sailing Instructions will be on the official notice board located at <https://www.sea-ventures.co.uk/race-yachts-super-series>

## 5. COURSES

- 5.1 Courses will be a mixture of windward leeward races and round the cans races. Races will use fixed metal race marks, and may include inflatable laid or robotic marks.



- 5.2 Racing charts of the Solent with mark designations are available from The Solent and Racing Association website: <https://www.scra.org.uk/solent-marks/solent-marks2>
- 5.3 Start Lines and Finish Lines for the series shall consist of Fixed Sailing Club Lines, Transit Lines, Committee Boat Lines – further information of the vicinity of these will be shared in the Sailing Instructions
- 5.4 Competitors may be required to record their finish times along with boats ahead/behind them.

## 6. PROVISIONAL SCHEDULE

- 6.1 The intended schedule is as follows:  
Three races are scheduled per weekend with two races sailed on the Saturday starting in the central Solent finishing in the host port of the Round. Sunday's race will start in the vicinity of the host port with its finish being located in the central Solent.
- 6.2 Round 4 will consist of 2 races followed by an evening social and overall prize giving in Hamble.
- 6.3 Except as a result of a general recall, no warning signal will be displayed after 14:30 on Saturdays or after 12:00 on Sundays.

## 7. COMMUNICATION

- 7.1 The online official notice board is located at: <https://www.sea-ventures.co.uk/race-yachts-super-series>
- 7.2 All boats shall carry a VHF radio capable of communicating on Channel 37a
- 7.3 The race committee will make broadcasts to competitors on VHF **Channel 37a** broadcasting courses etc. Regatta information and where possible course information will be shared on the WhatsApp Group [courses not received via Whats App shall not be grounds for redress.]
- 7.4 From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.
- 7.5 To be considered an entry, a boat shall complete all registration requirements.



7.6 Eligible boats may enter by completing and submitting the Sea Ventures Super Series entry form by the 25<sup>th</sup> October 2023 online at: <https://www.sea-ventures.co.uk/race-yachts-super-series>

7.7 Feedback is welcome and encouraged at any time, a weekly review Zoom Call will take place every Wednesday following each Round of racing at 19:30. Call information will be shared with competitors

## 8. CREW LIMITATIONS

8.1 A boat shall sail with a minimum of 2 and a maximum of 4 crew.

## 9. ADVERTISING

9.1 Boats may be required to display advertising chosen and supplied by the organising authority.

9.2 Boats may be required to fly event sponsor flags when **sails are not hoisted** on race days i.e. when transiting from berth to race area, when transiting from race area to berth at host port, overnight at a host port (weather permitting), and after racing and returning to home berth. Flags shall be supplied by the organising authority. Should teams not comply the OA may issue penalties

## 10. BRIEFING

10.1 No live briefing will take place – briefing notes will be shared with the fleet via a WhatsApp Group.

## 11. BERTHING

11.1 A nominated marina at the host port will be communicated to competitors for each round. Competitors are responsible for organising and paying for their berth at each round, use of the nominated marina is encouraged but not mandatory:

> 28<sup>th</sup> October – Cowes  
> 11<sup>th</sup> November – Lyminster

> 25<sup>th</sup> November – Yarmouth  
> 9<sup>th</sup> December – Hamble

## 12. PENALTY SYSTEM

12.1 The Two-Turn penalty in RRS 44.1 will be replaced by a single penalty turn.

## 13. SCORING

13.1 The Low Point System of Appendix A will apply

## 14. DIVING EQUIPMENT

14.1 For clarity boats may be lifted and cleaned or dived in between rounds.

## 15. DATA PROTECTION

15.1 By participating a competitor automatically grants the Organising Authority and the event sponsors the right in perpetuity, to make, use and show still and motion pictures taken during the period of the event without compensation. The Organising Authority will not release personal contact details of competitors to third parties or to the internet.

## 16. RYA CHARTER

16.1 Competitors should note that Island Sailing Club implement the RYA Racing Charter and that competitors will be required to undertake to sail in compliance with the Charter, which can be



found at the front of the RYA rule book (Racing Rules of Sailing 2021-2024) or at [www.rya.org.uk/racing/charter](http://www.rya.org.uk/racing/charter)

## 17. RISK STATEMENT

17.1 RRS 3 states: “The responsibility for a boat’s decision to participate in a race or to continue racing is hers alone,”

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part series, each competitor agrees and acknowledges that:

- a. They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the series;
- b. They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c. They accept responsibility for any injury, damage or loss, to the extent caused by their own actions or omissions;
- d. Their boat is in good order, equipped to sail in the series and they are fit to participate;
- e. The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own (the competitors’) responsibilities;
- f. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- g. It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
- h. They are responsible for ensuring that their boat is equipped and seaworthy so as to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew.
- i. Their boat is adequately insured, with cover of at least £3,000,000 sterling against third party claims.

## 18. DISCLAIMER OF LIABILITY

- a. The attention of all competitors is drawn to RRS Fundamental Rule 3, ‘Decision to Race’
- b. A boat is entirely responsible for its own safety whether afloat or ashore, and nothing, whether in the Notice of Race or Sailing Instructions or anywhere else reduces this responsibility.
- c. It is for the boat to decide whether it is fit to sail in the conditions it finds itself. By launching or going to sea the boat confirms that it is fit for those conditions and that its crew is competent to sail and compete in them.
- d. The boat is responsible to ensure that it is equipped and seaworthy so as to be able to face extremes of weather; that there is crew sufficient in number, experience and fitness to withstand such weather and that the safety equipment is properly maintained, stowed and in date and that the crew know how to use it.
- e. Nothing done by the Organisers can reduce the responsibility of the boat nor will it make the Organisers responsible for any loss, damage, death or personal injury; however it may have occurred, as a result of the boat taking part in the racing.
- f. The Organisers encompass everyone helping to run the race and the event, and include the Organising Authority, the race committee, the race officer, patrol boats and club Bosun.
- g. The provision of patrol boats does not relieve the boat of its responsibilities.
- h. The fact that the race committee conducts inspections of a boat does not reduce the responsibilities of the boat set out in this section.



## 19. INSURANCE

19.1 Each participating boat is required to hold insurance cover and in particular to hold adequate insurance against third party claims with a minimum cover of £3,000,000 per incident.

## 20. PRIZES

20.1 The winner of the Sea Ventures Super Series will be the team with the lowest points accumulated over the four rounds.

20.2 Overall prizes shall be awarded for Double Handed and Crewed (4 up)

20.3 Prizes for each Round will be awarded on the Saturday of each following Round, The prizes for Round 4 and the Overall winner prizes will be awarded on Saturday 9<sup>th</sup> December at the prize giving to be held in Hamble at a location to be announced.
